CHINOOK WEST'S MISSION IS TO SUPPORT AND PROMOTE EACH STUDENT'S EDUCATIONAL GOALS AND LIFE ASPIRATIONS. UPON GRADUATION, CHINOOK WEST STUDENTS ARE PREPARED TO MAKE RESPONSIBLE CHOICES ABOUT EMOTIONAL AND PERSONAL WELL-BEING AND HAVE THE LIFE AND ACADEMIC SKILLS TO ACCOMPLISH THEIR GOALS. IN SEPTEMBER 2015, TEENS, INC. BEGAN ADMINISTERING THE SECONDARY AND POST SECONDARY EDUCATION PROGRAMMING AT LOOKOUT MOUNTAIN YOUTH SERVICE CENTER - THE LARGEST YOUTH CORRECTIONS FACILITY IN THE STATE.
